KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a stock corporation under the laws of the Republic of the Philippines.

THAT WE HEREBY CERTIFY:

FIRST: The name of this Corporation shall be:

PROPERTY SPECIALISTS RESOURCES, INC. doing business as Quest Hotel and Conference Center -- Cebu

SECOND: A. That the purposes for which this Corporation is formed are:

PRIMARY PURPOSE

To purchase or otherwise acquire and own real property and personal property of all kinds, to sell, use, assign, transfer, dispose, hold, mortgage, lease, maintain, manage, construct, contract for, improve, develop and administer, alone or jointly with others, any interest in real or personal property as well as in hotels to cater only to hotel and resort clients, inns, resorts, lodging houses and all adjunct and accessories thereto, including restaurants, cafes, bars, stores, offices, barbershops, beauty lounges, sports facilities, places of amusement, and entertainment of all kinds; or to grant concessions, rights or licenses to others to operate, manage, or deal with the same; to do any and all things necessary, suitable, convenient, proper or incidental to the accomplishment of the business of hotelkeepers and innkeepers, or for the enhancement of the value of the Corporation.

SECONDARY PURPOSES

- A. To act as a foreign exchange dealer (FXD), money changer (MC) or to engage in the business of buying and/or selling currencies on real time basis; to act as a Remittance Agent (RA) or to engage in the business of remitting money on behalf of any person to another person and/or entity (as amended by the Board of Directors and Stockholders of August 24, 2016.)
- B. That the Corporation shall have all the express powers of a corporation as provided for under Section 36 of the Corporation Code of the Philippines.

THIRD: That the place where the principal office of the Corporation is to be established at Basement 1, Quest Hotel & Conference Center, Archbishop Reyes Avenue corner Apitong and Solon Sts., Brgy. Kaputhaw, Cebu City.
